PARKERSBURG, IOWA The City Council of the City of Parkersburg, Iowa met in regular session on Monday, November 7, 2022 at 7:00 P.M. at the Parkersburg Civic Center. Council members present: Abkes, Bruns, Cuvelier, Goodrich, and Johnson. Mayor Mike Timmer called the

Mayor Mike Timmer called the meeting to order and led those in attendance in reciting the Pledge of Allegiance.

There was a motion by Abkes, seconded by Cuvelier to approve the agenda. Upon vote, all ayes.

There was a motion by Bruns, seconded by Goodrich to approve the appointment of Bruce Toenjes as City Attorney. Upon vote, all ayes.

There was a motion by Johnson, seconded by Abkes to approve the minutes. Upon vote, all ayes.

There was a motion by Goodrich, seconded by Abkes to approve the bills. Upon vote, all ayes. Tim Kolder provided an update of

the infrastructure and street repair projects recently completed, included numerous storm sewer intakes a

that were repaired. Mayor Timmer presented information about the accidental death and

to a financial/coverage agreement that works for both communities. City Attorney Bruce Toenjes advised that the current agreements in place require a notice be provided prior to discontinuance and that the agreements should be reviewed further before action is taken. Upon vote, ayes: none. Nays: Abkes, Bruns, Cuvelier, Goodrich, and Johnson. Motion failed. City Attorney Bruce Toenjes further

advised that an appropriate motion would be to have city staff discuss with Butler County the agreements that are in place in order to provide the notice of the intent to discontinue providing ambulance coverage. There was a motion by Goodrich, seconded by Bruns to direct city staff to meet with representatives from Butler County to proceed with drafting the notice as required. Upon vote, all ayes.

There was discussion about adding fees to the Code of Ordinances for ambulance calls that only require a lift assists, no transports, and/or a patient refusal(s). There were no objections with publishing notice of a public hearing to consider adding these fees for the next regularly checklude city coupling the

scheduled city council meeting. notion by seconded by Bruns to approve the EMT training reimbursements to Stephanie Jansen for the class that she is currently enrolled in to become certified. Upon vote, all ayes. An update was provided for the Memorial Library which included the recent Halloween programming party sponsored by Lincoln Savings Bank and the Aplington and Parkersburg Friends of the Library. At the Trick and Read event, over 174 attended and books were given away to over 110 children which were do nated by the Friends of the Library Lee Gallentine provided an update of the Grant/Johnson/2nd Street watermain project. He stated the final pay estimate paperwork is nearing completion. He also provided change order #6 for additional materials used under the concrete beyond the specifications and for additional line stripping that was done. There was a motion by Goodrich. seconded by Abkes to approve the change order for an additional \$7.046.30. Upon vote, all aves. Lee provided an update on sanitary sewer lining project. He stated that Hvdro-Klean finished the televising and the inspection is currently ongoing. Lee provided for consideration an additional Special/Supplemental Engineering Services Agreement for the Sanitary Sewer Lining project for work required that is beyond the control of the engineer and for work which the engineer is not responsible for. This work to be provided in accordance with CGA's normal hourly rate schedule as provided. There was a motion by Cuvelier. seconded by Abkes to approve the supplemental engineering services agreement. Upon vote, all ayes. There was discussion about New ell Avenue and the surveying and preliminary engineering work that needs to be done in order to properly repair the roadway and to plan the improvements that need to be completed. There was discussion about the potential improvements that are being proposed to improve accessibility and to improve safety for the residential area. Grant funding for the future project was also discussed as well. There was a motion by Bruns, seconded by Johnson to approve the Engineering Services Agreement for the Newell Avenue Reconstruction project. Upon vote, all aves. There was a motion by Bruns, seconded by Abkes to adopt Resolution 1088 approving the FY2022 Street Finance Report. Upon vote, all ayes. Mayor Timmer opened the public hearing for the proposed Amendment to the Parkersburg Urban Renewal Area. There were no public or written comments filed on behalf of the amendment. Chris Luhring provided a description of the amendment and the legal reasons that require it. Upon no further discussion, Mayor Timmer closed the public hearing. There was a motion by Bruns, seconded by Goodrich to adopt Resolution 1089 approving the Urban Renewal Plan. Upon vote, all ayes. Maggie Burger, Speer Financial, provided the FY2022-2023 tax increment finance and debt service report. Maggie highlighted the city's growth of over 10% since last year and the development expected in the future. She reviewed the current TIF obligations outstanding and the city's 72% of debt service capacity remaining. Maggie also provided information about the unclaimed TIF dollars that the city releases back to the county, school district, and to the community. She commended the city's position and long-term plans. There was a motion by Goodrich, seconded by Cuvelier to approve of the FY2024 TIF debt certification and obligations. Upon vote, all ayes. Mayor Timmer opened the public hearing to adopt Ordinance 375 and Ordinance 376 amending the provisions of Parkersburg Code of Ordinance Chapter 92 and Chapter 95 by adding annexation requirements as a condition of city water service and/or sanitary sewer service being provided to properties located outside of the city's corporate limits. Chris Luhring spoke on behalf of the city precedence for water and sewer service to be provided to properties that are outside of the corporate city limits. Mayor Timmer read the amended Ordinance language

as a condition of City Sanitary Sewer Service being provided to properties located outside of the city's corporate limits. Upon vote, all ayes. There was a motion by Bruns, seconded by Goodrich to adopt Resolution 1090 approving the City of Parkersburg Water Service Contract for administering the Parkersburg Zoning Ordinance #375 for properties located outside of the city's corporate limits. Upon vote, all ayes. There was a motion by Cuvelier,

seconded by Abkes to adopt Resolution 1091 approving the City of Parkersburg Sanitary Sewer Service Contract for administering the Parkersburg Zoning Ordinance #376 for properties located outside of the city's corporate limits. Upon vote, all ayes.

Mayor Timmer opened public comments in reference to the second reading of Ordinance 374 to consider the rezoning of the property described as Parcel Letter 'I' as surveyed in County Recorder's Instrument No. 2007-1582 located in Outlot 'A', Legend Trail Development to the City of Parkersburg, Butler County, Iowa EXCEPT any portion contained within Parcel V as surveyed in County Recorder's bank can function without the additional parking spaces and that a parking lot will bring no additional property taxes to the community and only create a thoroughfare. He also questioned whether the Ordinance that states development cannot have a negative impact on the sur-

rounding area will be applied. Kyle Rice, on behalf of Green Belt Bank & Trust, spoke in favor of the rezoning of the residential lot to provide additional parking for the bank. He stated his desire for more parking spaces to serve the bank's needs now and in the future as they expand. Mr. Rice stated their goal is to not create a safety hazard in the area. There was discussion about the number of parking spaces needed and the number of parking spaces in other locations. There was also discussion about other options potential options for parking in the area. Kirk Young also spoke in favor and stated the bank will do what it can do to promote safety. Chris Weaver, owner of the bank stated that the bank's desire is to bring value to the area, not to create problems, and to be good neighbors. There was additional conversation about the existing use of the

dismemberment coverage provided to the fire department and the ambulance service volunteers. There was a motion by Abkes, seconded by Johnson to provide the coverage at a rate not to exceed \$19.00/member. Upon vote, all ayes.

There was discussion about the funds being raised to purchase a LUCAS 3 Chest Compression System for the ambulance service. It was stated that a majority of the funds have been raised so far but the ambulance crew would like the city's support until the remaining funds can be raised. There was a motion by Goodrich, seconded by Abkes to approve up to \$3, 000.00 to support the purchase. Upon vote, all ayes.

Councilman Cuvelier discussed the number of calls that the Parkersburg Ambulance Service has covered for Aplington and the burden that this has placed on our own ambulance volunteers. Councilman Cuvelier has initiated several conversations over the past several months with the Mayor of Aplington with the goal of finding solutions for the burdens on both communities. Cuvelier provided a sample agreement to Aplington's Mayor for consideration in order to help move forward with the financial strain. The suggested agreement provided financial support of \$200.00 per call to both entities in the event that the Parkersburg Ambulance Service responds to a 911 call for service in Aplington's coverage territory and for when Aplington's ambulance covers a 911 call for service in Parkersburg's coverage territory. Cuvelier acknowledged that while this agreement will not eliminate the shortage of volunteers, it will help relieve some of the financial burden Cuvelier stated the response from Aplington's Mayor was that their elected officials were not interested in approving the financial support for 911 ambulance calls. Councilman Cuvelier suggested that we suspend covering 911 ambulance calls for Aplington because of the negative impact it is having on our own ambulance service.

Councilman Goodrich asked about what would happen if there was a serious event at the Middle School or another situation like a school bus accident. It was stated that our current mutual aid agreements would still provide for a response by Parkersburg EMS to provide assistance in those types of situations.

Councilman Cuvelier reemphasized that the number one goal is to avoid burnout of our own volunteers so that we can continue to provide dependable service. He commended the leadership of Ambulance Chief Leon Schwerdtfeger and the dedication of all of the volunteer EMTs and drivers who donate their time to respond to all of the calls for service and for the additional time and dedication, especially in the last twelve months.

There was a motion by Abkes, seconded by Cuvelier to discontinue providing any 911 ambulance response for Aplington until they can either fully staff their own ambulance service or until they commit he owns land outside and inside of city limits and that he would like to run city water from his property inside of city limits to his property outside of city limits. There was discussion about annexation and the use of a development agreement to provide access to city water and/ or city sanitary sewer services in his situation. There were no other oral or written comments for or against the proposed Ordinances under consideration. After the discussion concluded, Mayor Timmer closed the public hearing.

Resident Steve Wicks stated his opposition to the rezoning because the proposed store location does not fit in the residential area along Newell Avenue. Mr. Wicks stated other projects recently completed in town such as the Diamonds and Fields project, etc. are good projects and their locations make logical sense. He stated his safety concerns for bicyclist, runners, and walkers due to increased vehicle and semi traffic on Newell Avenue. Mavis Wicks voiced her opposition to the rezoning of the parcel due her concerns for the safety of children and families who live and play in the area. Dave Mansheim voiced his opposition due to the commercial location not fitting and he reiterated the comments of Steve Wicks. Linda Blevins also stated her opposition due to the safety concerns for those who use Newell Avenue to run or walk with their families. She also stated a store in that location would ruin the landscape and hurt the property values in the area. Lance Ibeling stated his opposition since the proposed store location does not fit in the area from a city planning standpoint. He also stated his safety concerns for his family. Upon no further comments being given, Mayor Timmer closed the meeting to public comments.

Attorney Bruce Toenies provided his opinion in regards to considering the second reading of Ordinance 374. After discussion, there was a motion by Goodrich, seconded by Abkes to approve the second reading of Ordinance 374 to consider the rezoning of the property described as Parcel Letter 'l' as surveyed in County Recorder's Instrument No. 2007-1582 located in Outlot 'A', Legend Trail Development to the City of Parkersburg Butler County, Iowa EXCEPT any portion contained within Parcel V as surveyed in County Recorder's Instrument No. 2016-2253. Upon rol call vote, ayes: Abkes. Nays: Bruns, Goodrich, and Johnson, Abstain: Cuvelier. The motion failed. Mayor Timmer opened the public

hearing for the purpose of considering an application for rezoning property from "R-1" Residential District to "B-1" Commercial District for the legal description as follows: Lot 6 in Guggisberg Addition with a parcel number 1531102006.

Mayor Timmer read a letter of opposition from resident Dennis Knock who lives on the same block as the proposed rezoning. Mr. Knock wrote the rezoning would negatively affect his property value and the property values of his neighbors. He also stated that it would cause a dangerous situation for those that live on Conn Street and Dorothy Street and it is asking for trouble. He wrote that if the community is going to go to only supporting businesses against the residents who have lived here a long time, then he does not want to live in Parkersburg anymore.
