The Aplington City Council met in regular session on May 14, 2025. Mayor Mehmen, called the meeting to order at 6:00 p.m. Council members present: Jacobs, Klahsen, Noble, and Lage. Absent: Wolff
A motion by Jacobs, seconded by Lage, to approve the consent agenda, which includes the agenda, minutes of the April 16, 2025 meeting, financial report ending April 2025, and a list of claims for approval, carried unanimously.
Public Works Department: Mike Meyer spoke of the need of new tires for the 2022 F-250. A motion by Jacobs, seconded by Lage, to approve the purchase of a set of new tires, carried unanimously. City-wide clean-up days are May 23 from 9-6 and May 24 from 9-3.
Police Department: Chief Matt Lind spoke of fines for nuisances. A proposed change in the ordinance was tabled until next month.
Fire Department: Matthew Klahsen gave an update on the Community Project Funding Grant. Ashley Hinson's office will make a decision within the next 6 weeks.
Alexis Karsjens, Library Director, reported the library has the summer program schedule done. A bench will be placed outside of the Library in honor of long time Library Board member, Marilyn Klooster, donated by her fellow card club members.
Ambulance: Chief Frances Krull

asked for the Council's approval for Tryston Adelmund to join the crew as an EMT. A motion by Lage, seconded by Klahsen, carried unanimously.
Pool: City Clerk spoke on behalf of the committee. The committee is continuing to campaign and will have a booth at RAGBRAI.
Ordinance 221-23 Amending Section 106.08 Collection Fees. The Council discussed raising the Collection fee to \$21.00 and reducing vacant residences to \$15.00 beginning July 1, 2025. The Ordinance will be on the June 18, 2025 open meeting agenda for approval.
