designation, "A-1" Agriculture, on a parcel legally described as follows: All that part of the Northwest Quarter (NW1/4) of Section Thirty-four (34), Township (92) North, Range Fifteen (15) West of the 5th P.M. in Butler County Iowa Iving southwest of Highway #3 and consisting of 73 acres, more or less.

Section 2. ADOPTION. This Ordinance adopts in lieu thereof a new zoning designation "A-2" Limited Agricultural for the property legally described above, on the Official

Zoning Map. Section 3. INTEGRATION WITH CODE. Each section, provision or part of this Ordinance which is followed by a section number shall be inserted in the Butler County Zoning Ordinance (Ordinance No. Title VI, Number 28, adopted on November 1, 2022) as indicated by said section number and hereafter shall be cited by reference to said section number. Section 4. REPEALER. All ordinances and resolutions, parts thereof or amendments thereto, in conflict with this Ordinance are hereby repealed.

Section 5. SEVERABILITY OF RE-PEALER. All ordinances and resolutions, parts thereof or amendments thereto, not directly affected by this Ordinance shall remain in full force and effect.

Section 6. SEVERABILITY. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such section, provision, or part shall be severable from the rest of the Ordinance, and such adjudication shall not affect the validity of the ordinance as a whole, or any section, provision or part not adjudged invalid or unconstitutional. Section 7. EFFECTIVE DATE. This Ordinance shall be in full force and effect after its final passage and publication as provided by law.

ing at 5:30p leading with the Pledge of Allegiance and requesting approval of the agenda which brought a motion from Brewer 2nd by Ragsdale to approve June 5, 2024 agenda with vote being all ayes motion carries.

During Public Forum Adams presented a petition he put together requesting an updated flood mitigation procedure. During discussions the Mayor and Fire Department members explained there has been briefing meetings and conversations with engineers putting into motion an action plan. The informational inconsistencies received during the water event and the reactions that had taken place were above and beyond. This unexpected situation teamed together with many experts such as Chris Showalter the Butler County Emergency Management, John Riherd Butler County Engineer, Jon Beiderman Fehr Graham Engineering, Rusty Eddy County Supervisor, New Hartford Fire Dept and many citizens jumping into action helping with sandbags and volunteering equipment.

Motion made by Ragsdale to approve road closure from north side of Main Street starting at Packwaukee St down to Martin Memorial Library for the annual Fireman's Dance scheduled for July 20th 2nd by Perez with vote being all ayes motion carries. Swarts adds the Omelet breakfast and spaghetti dinner for the Fireman's gear fundraisers was very successful.

Motion made by Woods 2nd by Brewer to approve Walter's garage building permit application at 1120 Main St as long as the project is reduced to 600 sq ft so the garage can be constructed at grade with flood vents that provide one square inch of opening for every square foot subject to flooding; the project needs to be anchored to stay in compliance with the Flood Ordinance with the vote being all ayes motion carries.

Motion to approve Kugel's backdoor step building permit 810 Saratoga St made by Johnson 2nd by Radsdale with the vote being all ayes motion carries.

With the quest of a new city pickup and the possibility that the prospective truck will be sold by next council meeting a motion was made to give the Mayor authority to purchase truck by Johnson 2nd by Perez with the vote being all ayes motion carries. Additional conversations brought the idea of Deluxe Auto checking out chassis for rust and simply replacing the motor. This will come after additional research of the existing engine for a possible fix has been made.
